Under the New Education Policy the curriculum is divided on the basis of 5+3+3+4 instead of the current system of 10+2 model. The policy is based on the guiding objectives of capacity, quality, affordability and accountability. There are four stages in the policy-Foundation stage (policy for 3yrs to 8yrs children) fixed for 5 years, preparatory stage (8yrs to 11yrs) kept for 3 years, Middle stage(from 6th to 8th grade) fixed for 3 years, Secondary stage(from 9th to 12th Grade) fixed for 4 years.

NEP 2020 is aimed at ensuring universal access to all levels of education system, focussing on early childhood care and education, enabling the teacher to use a variety of techniques and experiments for learning, giving the students the freedom to choose any subject or stream without any restrictions. In short NEP 2020 focuses more on practical than theoretical training.

3. Statement of Problem

The emphasis of the study is to know the level of awareness about the changes that has taken place in the education system among the college students.

4. Objectives of the Study

The following are the objectives of the study:

- 1. To study the level of awareness of NEP 2020 among college students.

6. Analysis of Data


6.1: Demographic distribution of respondents


6.2: Awareness of changes incorporated in educational system

From the table above we can interpret that only 86% of the respondents are aware of the changes made in the Educational system and 14% aren't aware of the same.


6.3: Awareness regarding NEP-2020

From the table above we can interpret that 78% of the respondents have heard about the term New Education Policy-2020 and where as 22% hasn't heard of the same.


6.4: Opinion regarding NEP-2020


6.5: Possible Outcomes of NEP 2020(from Student's Point of View)
